## BOARD OF ELECTIONS AUDITS EARLY VOTING RESULTS; REVISES UNOFFICIAL RESULTS

**Charlotte, NC** – The Mecklenburg County Board of Elections has completed a manual audit of votes cast during the early voting period. The audit is part of the election certification process in accordance with North Carolina law.

As a result of the audit, the unofficial results for **EARLY VOTING** have been revised, as follows. The results from the 2004 General Election will not be official until Tuesday, November 9, after the tabulation of all provisional ballots. Mecklenburg County has more than 6,000 provisional ballots which have yet to be counted.
